Ninaj Raoul is a co-founder and Director at Haitian Women for Haitian Refugees (HWHR) in Brooklyn, New York, an organization founded in 1992 to respond to the human needs of Haitian refugees and immigrants in the U.S., fleeing persecution. Through education, community organizing, leadership development and collective action, she has been working with HWHR members to empower themselves as they struggle for social, economic and racial justice. Over the years, HWHR has conducted leadership and organizing trainings for adult literacy learners, to address the root causes of migration and developed brave culturally-grounded healing spaces to engage in survivor informed practices to address the impact of individual and community trauma. Her current work with HWHR involves local organizing and advocacy efforts for refugees, undocumented immigrants and survivors of violence, to build power and resist racist policies. Ninaj is the daughter of Haitian immigrants and she has often traveled to and from Haiti, where HWHR has worked in solidarity with women-run organizations that respond to manmade and natural disasters

Susan Butler Plum

Susan Butler Plum was the former founding director and is now senior advisor and Trustee of the Skadden Foundation, which awards two-year grants to 28 public interest attorneys per year. The Foundation was established in April 1988 and has made grants to 934 attorneys. Prior to joining Skadden, Ms. Butler Plum was the director of the Botwinick-Wolfensohn Foundation and program director of the Booth Ferris Foundation. She also was the associate director for the Environmental Defense Fund. She is a graduate of the University of Miami. Among her board affiliations are trusteeships of the Stella and Charles Guttman Foundation, and of the Community Opportunity Fund. Further board service includes member positions at Deaf Legal Advocacy Worldwide and Justice Labs, among others. in 2015 Ms. Butler Plum was selected as one of 50 inspiring Change Makers worldwide by the Harvard Law and International Development Society and the Harvard Women's Law Association.



Right to Counsel NYC Coalition

The Right to Counsel NYC Coalition is a tenant-led, broad-based coalition that formed in 2014 to disrupt Housing Court as a center of displacement and stop the eviction crisis that has threatened NYC families, neighborhoods and homes. The Coalition is made up of tenants, organizers, advocates, legal services organizations and more. Their work is rooted in principles of equity, dignity, humanity, diversity and justice. After a hard fought, 3 year grassroots campaign, led by this coalition New York became the first city in the nation to establish a Right to Counsel for tenants facing eviction. This campaign has inspired a movement across the country. They are building campaigns for an eviction-free NYC and ultimately for a right to housing. They are running direct action campaigns against NYC's worst evictors, changing the laws to stop evictions, supporting the development of passionate and zealous attorneys committed to tenant power, and expanding and strengthening Right to Counsel so that it extends to all tenants.
